

And whereas the Trustees have agreed to carry out the Trust herein created.



The settler as absolute owner has delivered cash amounting to Rs. 10,000 and will also arrange from time to time suitable funds and other assets for the purpose of the Trust on short term and long term basis to the trustees to hold the same unto and to the use of the Trustees upon trust and with, under the subject to the powers and provisions herein contained.

- 3. The name of the Trust shall be 'M/S ROOP CHAND RAM JI LAL EDUCATIONAL TRUST.'
- 4. Powers and duties of the Trustees
 - a. The Trustees will do all the needful to establish and create the infrastructure of the institutions and other set-ups as above mentioned under the trust.

b. The Trustees have a power to form a management committee with office bearers such as Chairman, Vice chairman, Director, Treasurer, manager etc. for the purpose of the day to day management of the activities of the Trust and to fix their scope of work as to fulfill the objects of the Trust. Trustees can be the members of this committee. They can also take members from out side, if they unanimously, so deem fit.

c. The Trustees shall employ such staff as they think necessary for giving the necessary human resource infrastructure and set up in the field of education and services to fulfill the objects of the trust and replace them

whenever they deem it necessary.

d. Out of the receipts of the trust Fund which will also include aids, grants, donations etc. received by the Trust, the Trustees shall defray the expenses for the running and managing of the institutions and other set ups as aforesaid and capital expenditure for erecting building and creating other infrastructure for the purpose of the objects of the trust, but if the receipts are insufficient for that purpose the Trustees may use such portion of the corpus of the Trust Fund as may be necessary.

c. The Trustees shall have the power to borrow money from any bank, institution, individual or concern or otherwise on the security of the Trust property and to mortgage/ hypothecate the Trust property for this purpose.

f. The Trustees may invest the surplus funds in their hands in various movable and immovable properties and securities as they deem fit for the objects of the Trust.

g. The Trustees have the power to create new trust / society under the management and control of the existing Trust for the purposes of the

existing Trust.

The Settler shall also be one of the Trustees. All the trustees at the time of set 5. up of the trust shall remain as permanent trustees during their life time and after the demise of any of the Trustees, the spouse of such person will become the co-trustee. However, if spouse does not exist on this date then the eldest male member of his/ her family shall be a co-trustee, if however, there is no such male member exist on that day then the eldest female member shall be the co trustee.

The Settler will be the First chairman of the Trust meetings for a period of one 6. year. And will remain so unless otherwise resolved in future meetings of the

trust with at least 51% vote in favour of the proposed person.

If any of the Trustees becomes bankrupt or found guilty by court of an 7. offence involving moral turpitude or become insolvent or remains absent from India for a period of six months with out any notice to the effect to the managing committee of the trust or resigns from his/ her post or otherwise incapacitated physically or mentally, the remaining trustees with the consent of the settler so long as he/she is alive may appoint his/ her substitute, if deemed necessary.




